

### About the Moratorium NOW! Coalition:

The Moratorium NOW! Coalition to Stop Foreclosures, Evictions & Utility Shutoffs was formed in 2008 as the foreclosure crisis struck Detroit. We fought in the courts and through direct action to stop individual foreclosures. But we realized that for every home we saved thousands more were being lost. Only a moratorium – a freeze – on foreclosures could stop the devastation.

It turns out that during the Great Depression of the 1930s 27 states enacted moratoriums on foreclosures under pressure of the mass struggle. Michigan had a 5 year moratorium during which no one could lose their home. In 1934 the United States Supreme Court upheld the constitutionality of the moratorium in Home Building & Loan Association v Blaisdell.

With the Federal takeover of Fannie Mae and Freddie Mac the federal government now controls about 75% of all mortgages. It has been shown that the banks carried on a criminal conspiracy to push racist, fraudulent and subprime loans. This raises the possibility of a national moratorium to halt foreclosures. Such a moratorium could be imposed by Executive Order by the president at absolutely no cost to the government.

Only a truly massive struggle in the streets, however, can force the banks and the government to accede to this reasonable, necessary and urgent demand. Today groups around the country are fighting foreclosures spurred by the Occupy movement. It's time for us to unite and up the struggle even more.
